PLEASE NOTE: Specific sanitary measures may have been implemented within the Club Hippique de Nice (see displays). They are supplementing these rules of procedure.

Article I:

Anyone wishing to practice horse riding at the Club Hippique de Nice, on a regular basis, is required to complete a membership application on a form which will be given to them at the same time as this General Internal Regulation.

Article II:

All members accept, by their membership, the clauses of these regulations.

Sanctions, ranging from temporary layoff to exclusion with or without restitution of the entry fee, may be taken against any member who does not comply with these regulations.

Article III:

Similarly, any visitor (rider, leader or boarder) accepts, by making an appointment, the clauses of these regulations.

The responsibility of the Club Hippique de Nice cannot be held liable in the event of an accident caused by non-compliance with the internal regulations.

Article IV:

Any member or visitor is required to show courtesy conducive to the serenity of the establishment.

Article V: Membership, Federal Licence

Membership of the Club Hippique de Nice requires the payment of an annual entry fee valid from date to date as well as the taking of the federal license of practitioner. If you already hold a valid federal license, a photocopy will be requested.

Only users holding a valid federal license are covered by the insurance associated with it The contact details of the insurer and the limits of guarantee appear on the licence.

The annual renewal of the federal license must imperatively be done from September 1 and in any case before December 31 of each year to avoid the risk of a breach of insurance cover.

Article VI: Parking

Vehicles must park in the areas provided for this purpose, making sure to leave free passage to safety and emergency vehicles.

Article VII: Access to club facilities

Access to the club facilities is reserved for users within the limits of opening hours.

Night access is strictly prohibited. In the event of a night departure on the move of a resident horse, a request must be submitted to the recention for the Director.

Dogs are only allowed on the premises of the equestrian center on a leash. Any accident caused by a dog on the loose engages the responsibility of its owner.

Article VIII: Circulation inside the club facilities

Motor vehicles must not travel at more than 15 km/h within the grounds of the equestrian center.

Article VIII: Circulation inside the club facilities (suite)

Visitors and members must ensure:

- . Do not approach horses without warning them and avoid gestures that could frighten them,
- Do not feed the horses anything in addition to their ration.

Children are under the supervision of their parents who must keep them out of reach of horses and ensure no noisy

Access to the stands of the exercices areas implies absolute silence. In particular, parents are urged not to intervene during the lessons, otherwise the teacher will be able to clear the stands or the surroundings of the arena.

It is strictly forbidden to enter the technical rooms without the presence of an employee of the Club Hippique de Nice as well as to use the reserves of shavings, straw, fodder and food.

Article IX: No Smoking

Smoking is strictly prohibited within club facilities.

Article X: Rates of services

The conditions of use and the prices of the services are annexed to these regulations. All services are payable in advance

The "FERs" (internal currency) and the entrance fee are neither transferable nor refundable.

Pensions are payable by bank transfer, no later than the 5th of the current month Beyond that, a delay surcharge of 1% per day of delay will be applied. Access to working sessions and courses is only possible after payment.

Article XI: Lesson schedules

Lessons take place according to the current weekly schedule. This is subject to updates each quarter.

In the event of a low number of students, lessons may be canceled or combined.

- « Shetland Accueil » lessons are complete with à 6 riders.
- « Shetland Bronze », « Shetland Argent », « Initiation Cheval/Poney» lessons are complete with 8 riders
- . « Shetland Or » lessons are complete with 9 riders.
- The other lessons are complete with 12 riders.

Riders can register in lessons of their level () or in a lower level, but never in a higher level lessons.

Some lessons include modules of two successive hours (1 hour Dressage, 1 hour Jump). Registration for the permanent schedule can only be done for the two consecutive hours. However, to the extent of available places, registrations in the daily schedule are possible either in the two-hour module, or in the 1st hour only

During school holidays, all lessons are maintained (except for the summer holidays: specific lessons schedules are implemented).

Article XII: Registrations, subscriptions, cancellations

There is 2 way to register for a lesson: as a "permanent schedule" (weekly automatical registration) or as a daily schedule (one time registration).

Any session held and not canceled the day before before 6 p.m. at the latest is due.

Cancellations are made only: at reception, by fax: +33 (0)4.93.83.12.45 or by email: contact@nicecheval.com No cancellation by phone will be accepted.

Riders who arrive late cannot in any case claim to catch up.

The riders of the daily schedule are asked to register the day before before 6 p.m. They may derogate from this rule within the limits of available places and horsery.

Article XII: Registrations, subscriptions, cancellations (suite)

Registrations can be taken:

- · directly at the reception
- by email: contact@nicecheval.com
- by internet (soon)

For the proper functioning of the equestrian center, each rider is invited to:

- be present at least 30 minutes before the start of the lesson in order to prepare your horse/pony (grooming, saddle_bridle)
- to plan the time necessary after the lesson for the care of the horses/ponies and the cleaning of the harness,
- to report any anomaly to the teacher in charge,
- do not leave a saddled horse/pony unattended.

Article XIII: Teacher Authority

Any rider entering the arena, the quarries or participating in a horseback riding trip is automatically placed under the direction of the teacher, whose instructions he must follow.

The teacher is the only one authorized to allocate horses and ponies.

No horse or pony of the club may be used without the consent of a teacher.

Article XIV: Personal harness

Riders can use their personal saddle provided that it is approved, for each horse, by the teacher. Any injury caused by personal harnessing entails the responsibility of the rider.

Riders must have a "nose-band" strap and a pair of closed front gaiters from Galop level 4

Article XV: Clothing and materials

A correct, clean and fitted dress, without being special, is essential

Wearing a bomb or any other brain protection in accordance with European standard EN 1384 is compulsory For:

- any riders riding in collective or individual lessons, including teachers and rider-owners,
- riders individually riding ponies or school horses,
- trainee sports educators and pre-training trainees,
- all minor riders regardless of their status, including for the private use of their own horse.

Adult rider-owners who, in the context of the private use (outside teaching) of their own horse, do not wish to wear EN1384-approved head protection, must provide a handwritten certificate discharging the responsibility of the Club Hippique de Nice in the event of accident. In the absence of a certificate, it will not be possible for them to ride without protection within the grounds of the Equestrian Center.

Wearing an approved helmet and back protection is mandatory for all riders regardless of their status and without possible derogation during training sessions on fixed cross-country obstacles.

Spurs, gloves and riding crop are required from Gallop level 4.

Article XVI: Use of the riding arenas and carrers

Before entering the exercise areas, if they are occupied, permission must be sought from the teacher present or, failing that, from those already present.

For obvious safety reasons, it is forbidden, except with the teacher's agreement, to work a horse/pony either on the lunge or mounted during a lesson on the same area.

Article XVI: Use of the riding arenas and carrers (suite)

The lessons given by the staff of the equestrian center always have priority in the use of the facilities. When the gymnastics areas are used in sections, separations must be put in place. The lighting of the exercice areas must be turned off as soon as they are no longer occupied.

Article XVII: Courses

The club organizes courses of one or more days during each school holiday period. Programs and prices are available at the club reception or on the club's website.

Payment must be made upon registration.

Article XVIII: Federal exams

The dates of the federal exams are fixed by the teachers when a group of at least 8 riders is ready to present themselves. These dates are communicated to members by means of posters and on the club's website. It is advisable to register in advance with the teacher to allow the organization of the tests (schedules).

The examination pass is subject to a debit in "irons" according to the scale annexed to the tariffs.

Article XIX: Reimbursement of competition fees

Participation in the various competitions assumes the reimbursement of the costs incurred by the Club Hippique de Nice and the payment of the fixed relaxations according to the scale appended to the prices.

Article XX: Boarding horses

All the terms and conditions concerning the boarding of horses at the Club Hippique de Nice are subject to specific internal regulations. (see the document "Internal Regulation for horse owners in boarding")

This regulation comes into force on July 11, 2007, it was modified and amended on 09/01/2008. 09/01/2009. 05/31/2013. 08/24/2015. 08/30/2017 and on 08/31/2020.
